Thank you for contacting CITB requesting information under the Freedom of Information Act (FOIA). In your email dated. Thank you for your email dated 28 October 2019, in which you asked:

My response is as follows:

1) How many employees are working for your organisation, including full-time, part-time, and contracted staff? 990. As of 30/10/2019 there are 927 employees which consist of: 827 full-time and 100 part-time. In addition, there are 63 contractors (62 full time 1 part time).

2) What is your annual intranet budget? None

3) What is your current intranet solution? (e.g. Invotra, Sharepoint, Kahootz, Umbraco We currently use SharePoint 2007 and are gradually moving content onto SharePoint online



4) How long have you been using this solution, and when does your contract expire? CITB has been using the Office 365 suite of solutions for around 2 years. It is on an annual renewal.

5) Do you work with an external partner to supply your intranet? If not, do you develop your intranet internally? CITB do not have an external supplier working on the intranet. Only content is updated, by in-house staff, no current development.

6) Which team/individual is responsible for managing your intranet internally? Digital Team

7) Which other organisations have access to your intranet? None

8) Do you share IT services with other organisations? No

9) Are you using the Office 365 suite? If so, which applications from the suite are in use? Yes we do use the Office 365 suite: MSOffice, SharePoint, Skype for Business, Teams, Yammer, MSDynamics and One Drive

10) Who is responsible for your intranet's procurement within the organisation? SSCL, our outsourced partner, who carry out our procurement activity.

11) Do you use Microsoft's Active Directory to manage your people data? If so, is your Active Directory (AD) managed on-premise or in the cloud? Yes – on premises with a copy synced to Azure AD
