CITB part of Swindon and Wiltshire's decade of growth

The Swindon and Wiltshire Local Enterprise Partnership (SWLEP) has ambitious plans for future growth in the area.

The Strategic Economic Plan sets out the area's aims to develop an economy that is world-renowned for innovation and entrepreneurialism. The area has strong growth prospects – the creation of 30,000 jobs was forecasted across Swindon and Wilshire between 2010 and 2020, twice the rate of growth predicted nationally.

To support this growth and address the needs of the future, the SWLEP will need to provide a level of housing to support this expanding population and workforce. Between 2016 and 2026 there is a requirement for 42,480 new homes to be built; 23,171 of which are required between 2016 and 2021 (thereby contributing 2.3% of the Government's target of building a million new homes by 2021).

Due to the importance of housing and infrastructure to local growth, the SWLEP's Strategic Economic Plan recognises construction as an important sector to support. The LEP is putting actions in place to ensure that the sector is enabled to deliver the area's growth ambitions. A construction sector development group has been set up in partnership with the SWLEP, Swindon Borough Council, Wiltshire County Council, Construction Excellence and CITB to deliver actions that will directly address the sector's needs, removing barriers and enabling development.

A range of activities has been undertaken and this has included an employer-focused construction skills event aimed at understanding the issues in recruitment and training of the construction workforce, and putting in place solutions to address these issues.

Work is also under way on a major housing development scheme at Wichelstowe in South Swindon. A joint venture is being developed between Swindon Borough Council and Barratt Developments to build over 3,000 homes. To ensure that this major development will provide the widest possible benefit, CITB has been engaged to embed employment and skills plans through planning and procurement agreements. CITB's Client Based Approach will ensure that the highest level of Apprenticeships, work experience and upskilling can be delivered throughout procurement and planning agreements.

Through such joint venture activities and the embedding of employment and skills into future construction projects, the SWLEP and its partners are ensuring continued economic growth, the development of a skilled local workforce and the employment of local people.
