Recommended Qualification Structure for Site Logistics Operations (Construction) Level 2

This structure has been recommended by employers and stakeholders from the above occupational area for organisations to form the basis of academic capability and competence outcomes. Qualifications with a competence outcome at the above level must have units derived from the following National Occupational Standards (NOS) and consist of the mandatory/optional groups as stated for the individual option route.

- VR365 v4 Segregate the area for highways works
- VR387 v2 Operate plant or machinery to lift and transfer loads
- VR391 v2 Operate plant or machinery to receive and transport loads
- VR392 v2 Operate plant or machinery used as work platforms
- VR396 v2 Direct and guide the movement of vehicles, plant or machinery
- VR397 v2 Arrange and secure plant or machinery equipment for transportation
